**CASE NUMBER: DDR-2-2024**

Application of First Baptist Church

Reason for request: Demolition of a portion of the existing structure that faces Madison Street. The existing education wing and chapel will be removed. The facade of the existing original sanctuary will be enclosed where the demolished portion of the building will be

removed. Stone will be salvaged from the demolished portions and reused to provide veneer for the patched portion.

Location of request: 488 Commerce Street further identified as County Tax Map 066K Parcel 013.00

**DDR-2-2024 Staff Comments**

- If demolition is allowed, it would allow the portion built in 1917 to be more prominently featured and possibly make it eligible for the National Register of Historic Places.
- Ideally, instead of surface parking replacing the demolished portion, something would be built back in its place.

Reason for request: New building design for a distillery and small assembly (tasting and tour) venue.

Location of request: 119 College Street further identified as County Tax Map 066G Parcel 007.00
